The Composite integrates quantitative analysis with rigorous fundamental research to construct a solid portfolio of 40 to 60 mid-cap stocks with exceptional growth profiles as measured by positive earnings surprise, positive and accelerating earnings per share growth, and positive earnings per share revisions. The Mid Cap Growth Composite was created on December 31, 1998.*

The U.S. Dollar is the currency used to express performance. Returns are presented gross and net of management fees and include the reinvestment of all income. Net of fee performance was calculated using actual management fees. The annual composite dispersion presented is an asset-weighted standard deviation calculated for the accounts in the composite the entire year. Policies for valuing portfolios, calculating performance, and preparing compliant presentations are available upon request.

The management fee schedule for the composite is as follows:

Fees are charged to clients on a quarterly basis. Fees are calculated as a percentage of assets under management and vary based upon the type of product and the total amount of assets under management. The percentage fee is expressed terms of basis points ("BPS") for our products. One hundred basis points equal 1%. All fees are negotiable.
